Call to Order

The meeting was called to order at 4:00 p.m. by Chair Betsy Cavendish.

Remarks of OAH CALJ Adams

Chief Adams:

- There are currently 3 ALJ vacancies. COST will interview 13 people on March 26th. The candidates will be on by the 3 voting members of The COST
- There were 41 Applicants for the position, some from the private sector
- Finishing up ALJ evaluations. Should start sending them out early next week
- Working on get Final Orders online. Now uploaded about 5,000. Most are DPW due to volume and lack of privacy issues. We are using a cloud based system.

Betsy Cavendish:

• Asked about jurisdiction by MOU

Chief Adams:

• Council accepted most of CCE's recommendations.

Sheryl Jackson:

• ACA requires an MOU

Chief Adams:

- Chairman Todd and staff very helpful. [Discussion regarding the history of MOU use at OAH, including the CCE report which discussed that MOUs make it appear that OAH could be improperly influenced by the paying agency.]
- Oversight hearing was in February; Mayor's Budget Hearing April 13

• Spring offensive. Re-energize the committees. Look at Court Rules. Standardizing templates

Betsy Cavendish:

• Jurisdictions going well?

Chief Adams:

• Yes, at the point where transfer requests come in. Would like to let people transfer but have to preserve brain power. We have some suggested tweaks to the UI Cluster. Carve out a subset for Workers Comp and Wage/Hour cases.

Betsy Cavendish:

• Any questions for the Chief?

Chief Adams:

• Thank you for your support. Please don't be shy and drop in. We are all committed to making it the best central panel.

Betsy Cavendish:

• Systemic Issues (computer systems), particularly human services matters (are the bugs fixed?); there were operational issues which caused a spike in cases on the front end resulting in benefits being cut (constitutional issues)

Vanessa Natale:

- People are getting notices of their benefits being cut when they did not received no notices because of filing requests for emergency hearing.
- There is a glitch in the DHS system. It is better, but still problematic. DHS has a resource issue not enough people.

ALJ Little:

- Admin review allows the agency to resolve matters before adjudication; it is required by legislation, but Petitioner does not have to go.
- Agency and Petitioner should resolve the matter; Petitioner should still retain benefits, provided, they filed timely so Petitioner is not without benefits.

ALJ Rushkoff:

- Admin review must be done within 15 days in Shelter cases. OAH hearing cannot happen before an admin review. Admin review takes about a month puts OAH in a bad situation of not following the statutory scheme by not providing petitioner with their statutory rights.
- DHS should review shelter rules
- Shelter should not enforce rules not reviewed by DHS
- In such a situation where DHS has not reviewed a rule enforced by the Shelter, should OAH enforce the rule?

ALJ Little:

• Statements are sent regarding the rules, but they often have no signature and the agency reps do not come to the hearings.

ALJ Rushkoff:

• There are some obvious rules in the statues.

Betsy Cavendish:

• What mechanisms are required of DHS? Did they approve the rules that the shelter is enforcing?

ALJ Little:

• Go forth with the hearing and ask for proof of an approved rule after the hearing.

Chief Adams:

- Various jurisdictions have meetings with the agencies.
- DHS only has three representatives per week to send to hearings
- OAH cannot get the number of hearings that we would like to have because of this
- And we cannot always get the messenger to carry back the message to the agency \
- Change cluster conversation every six weeks or so; Vanessa will research this issue with the judges and pass her finding on to the Chair.
- Director Bolling (not present); wanted to consider notice by email (service of process)

Betsy Cavendish:

- Is there any new business systemic issues?
- Canvass the PB cluster about additional challenges how do people get personal care assistance?
- Backlog of customers but ability of agency is slowed because only so many people can certify

Cheryl Johnson:

- DHCF Medicaid determinations
- Face to face interviews required; but problem with contractors doing it timely causing an extension in eligibility
- The problem stems from a lack of registered nurses; trying to fix
- Looking at amending the waiver applications
- Looking at allowing clinical social workers to do assessments

Betsy Cavendish: Any new business?

• Discussion regarding immigrants' justice – people not taking advantage of government access because of fear (of deportation, etc.); but no such issues at OAH
